Inland Revenue Board Malaysia (IRBM)'s e-Invoice mandates all businesses to implement it starting from 1 July 2025. Fail to comply could be fined up to 20,000 Malaysian Ringgit or 6 months imprisonment, or both.

To implement e-Invoice, one has to equip with essential e-Invoice knowledge which take time to acquire. Presently, there are few documents be released by IRMB which provide guideline of implementation to Businesses. Nevertheless, the technical contents and the volume of the documents could be a hurdle to the relevant personnels to comprehend them effectively and efficiently.
